# New study gives voice to Canadians on racism, discrimination and action.





### Voice of Canadians > At a glance

- Advancing Justice > A majority of Canadians want independent civilian oversight of the RCMP and a Black Canadians Justice Strategy to address anti-Black racism and discrimination in the criminal justice system.
- Fighting Hatred > Online hatred is a major problem according to a majority of Canadians and people want legislation to combat serious forms of harmful online content and call for support of victims of hate-crimes.
- Action on Reconciliation > Canadians want action on safe drinking water for Indigenous communities and a special federal prosecutor to pursue those who inflicted great harm on Indigenous children in Canada's residential school system.

- Upholding Employment Equity > Canadians believe managers and executives should be held accountable for employment equity, diversity, and inclusion goals and say the Canadian Human Rights Commission's accountability mechanism should be strengthened.
- More Welcoming Arts & Culture > Individuals that self
  identify as part of racialized communities assert that
  arts/cultural institutions could do a better job at creating
  experiences that are welcoming to a diversity of Canadians.
- Inclusive Environmentalism Ensuring that First Nations, Inuit and Métis peoples are full and equal partners in Canada's efforts to confront the climate crisis is important to a majority of Canadians. Conversely, people don't believe governments are doing enough to fight climate change.








This research gauged the opinions of Canadians on a number of equality and equity topics such as policing and justice, online and offline hate, reconciliation, employment equity, arts and culture and environmental racism. It focused on measuring support for a variety of proposed changes to bring forth more justice and equality in Canada as well as agreement levels with statements on representation in the arts and culture as well as impacts of climate change. It also focused on Canadians' views on reconciliation and FNIM community issues.

Nanos conducted an online representative survey of 2,018 Canadians, 18 years of age or older, between November 3<sup>rd</sup> to 8<sup>th</sup>, 2021.

The research was commissioned by the Canadian Race Relations Foundation and was conducted by Nanos Research.



### **Key Findings – Advancing Justice**

1

#### RCMP OVERSIGHT

Nearly six in ten Canadians (58%) support (score of 7-10 out of 10) the creation of an independent civilian oversight body of the RCMP. Just over one in two (53%) support prohibiting the RCMP from using excessive force for crowd control.

Canadians from the Atlantic region (mean of 7.5

Canadians from the Atlantic region (mean of 7.5 and 7.0 respectively) were more likely to support both those statements than residents of Quebec (mean of 6.7 and 6.4 respectively) and of the Prairies (mean of 6.8 and 6.4 respectively).

#### ANTI-BLACK RACISM IN JUSTICE SYSTEM

Close to six in ten Canadians (55%) support (score of 7-10 out of 10) the development of a Black Canadians Justice Strategy to address anti-Black racism and discrimination in the criminal justice system, with just over one in ten who oppose (12%; score of 0-3 out of 10). Women (mean of 6.9) were more likely than men (mean of 6.3) and younger Canadians (18-34)(mean of 7.0) were more likely than middle-aged Canadians (34-54)(mean of 6.4) to support this.



#### **BANNING CARDING AND STREET CHECKS**

Just over four in ten Canadians (44%) support (score of 7-10 out of 10) banning carding and street checks by the RCMP, while close to two in ten (18%) oppose this (score of 0-3 out of 10). Residents of the Atlantic region (mean of 6.5 out of 10) are more likely to support this than residents of Quebec (mean of 5.6 out of 10).





# **Key Findings – Fighting Hatred - Online**

1

#### **SEVERITY OF ONLINE HATE**

Nearly six in ten Canadians (58%) say that hateful and racist online content and behaviour is a major problem in Canada (score of 7-10 out of 10). This is consistent across Canadians of all age groups and regions.

2

#### **LEGISLATION FOR HARMFUL ONLINE CONTENT**

Close to four in five Canadians (79%) support (score of 7-10 out of 10) introducing legislation to combat serious forms of harmful online content. Canadians who identify as White (mean of 8.3 out of 10) and women (mean of 8.5) were more likely to support this than Canadians who identify as racialized individuals (mean of 7.8) and men (mean of 7.8).



#### FEDERAL GOVERNMENT DOING MORE

A majority of Canadians agree (37%) or somewhat agree (40%) that the Federal Government should be doing more to prevent the spread of hateful and racist content and behaviour online in Canada, with just over one in ten who disagree (six per cent) or somewhat disagree (seven per cent) with this.





# **Key Findings – Fighting Hatred - Online**

#### HATE SPEECH ONLINE

Canadians are over twice as likely to say they worry more about the impact of hate speech and racism on people it harms and the impact on society overall (56%) than to say they worry more about governments and social media companies being able to limit the rights of citizens to express themselves and protecting the privacy of users (21%).



#### **SOCIAL MEDIA PLATFORMS**

About three in four Canadians (76%) support (score of 7-10 out of 10) making social media platforms legally responsible for the removal of hateful and extremist content before it can do harm, and under seven in ten (68%) support requiring social media platforms to publicly provide data and information related to algorithms, content moderation, and other information pertinent to preserving the safety of online spaces and preventing harm.



### STRENGHTENING THE CANADA HUMAN RIGHTS ACT AND CRIMINAL CODE

Three in four Canadians (75%) support (score of 7-10 out of 10) strengthening the Canada Human Rights Act and the Criminal Code to more effectively combat online hate. Older Canadians (55 plus) (mean score of 8.4) were more likely than younger Canadians (mean of 7.4) to support this.





### **Key Findings – Fighting Hatred - Offline**

#### DEDICATED POLICE HATE CRIME UNITS

Over seven in ten Canadians (72%) support (score of 7-10 out of 10) ensuring that all major cities have dedicated hate crime units within local police forces, with about one in 20 who oppose this (six per cent). Women (mean of 8.0) were more likely than men (mean of 7.2) to support this.

#### NATIONAL STANDARDS FOR HATE INCIDENTS

About seven in ten Canadians (71%) support (score of 7-10 out of 10) establishing national standards for identifying and recording all hate incidents and their dispensation in the justice system, with less than one in ten who oppose this (six per cent). Women (mean of 7.9) were more likely than men (mean of 7.2) to support this.



#### SUPPORT FUND FOR SURVIVORS OF HATE CRIMES

Under two in three Canadians (63%) support (Score of 7-10 out of 10) establishing a National Support Fund for Survivors of Hate-Motivated Crimes to help survivors with any uninsured costs that they have had to bear. One in four (24%) are neutral about this (score of 4-6 out of 10).













### **Action on Reconciliation**

Canadians want action on safe drinking water for FNIM communities and a special federal prosecutor to pursue those who inflicted great harm on FNIM children in Canada's residential school system.

#### SAFE DRINKING WATER

A strong majority of Canadians (85%) support (score of 7-10 out of 10) ensuring there is safe drinking water in all First Nations, Inuit and Métis communities by 2026. About one in ten (11%) are neutral about this (score 4-6 out of 10) and two per cent are opposed (score of 0-3 out of 10).

#### PURSUING THOSE WHO INFLICTED HARM

Two thirds of Canadians (66%) support (score of 7-10 out of 10) appointing a special federal prosecutor to pursue those who inflicted great harm on Indigenous children in Canada's residential school system, with under one in ten (eight per cent) who oppose this. Canadians from the Atlantic region (mean of 7.9) were more likely to support this than residents of the Prairies (mean of 7.0).



### CEASING COURT ACTIONS AGAINST FIRST NATION CHILDREN

Just under five in ten Canadians (48%) support (score of 7-10 out of 10) having all governments cease court actions against residential school survivors and First Nations children, while over one in ten (13%) oppose this.

### NATIONAL COUNCIL FOR RECONCILIATION

About six in ten Canadians (61%) support (score of 7-10 out of 10), through legislation, establishing a federal National Council for Reconciliation to provide oversight and accountability for this process, reporting regularly to Parliament and Canadians. #### **INCLUSION GOALS IN PERFORMANCE REVIEWS**

Just under two thirds of Canadians (62%) agree (score of 7-10 out of 10) that managers and executives should have employment equity, diversity, and inclusion goals in their performance management reviews to hold leadership accountable on progress in these goals. Women (mean of 7.5) are more likely than men (mean of 6.8) to agree with this.

#### **HUMAN RIGHTS COMMISSION'S ACCOUNTABILITY**

Just under six in ten Canadians (59%) agree that the Canadian Human Rights Commission's accountability mechanism should be strengthened so that it can measure work and progress on employment equity, and diversity and inclusion, with less than one in ten (eight per cent) who disagree with this.



#### **EMPLOYERS COLLECTING DATA**

Under five in ten Canadians agree (score of 7-10 out of 10) that employers must collect anonymized sociodemographic data on all employees and reporting it to governments to better understand barriers or biases in their workforce (46%) or to better understand the makeup of their workforce and to create diversity and inclusion goals (48%). #### **EXPERIENCES WELCOMING TO ALL CANADIANS**

About one in two Canadians (48%) agree that arts/cultural institutions could do a better job at creating experiences that are welcoming to a diversity of Canadians, while under one in ten (nine per cent) disagree. Canadians who identify as racialized individuals (mean of 7.0) were more likely to agree with this than Canadians who identify as white (mean of 6.3).

#### SEEKING CONTENT MADE OUTSIDE CANADA

Canadians are more likely to disagree (39%) rather than agree (25%) that they seek out content made outside of Canada because it is more reflective of their ethno-cultural community. Canadians who identify as racialized individuals (mean of 5.9) were more likely to agree with this than Canadians who identify as white (mean of 3.7).



### **INCLUSIVITY OF FUNDING FOR CANADIAN ART**

Canadians are split when it comes to whether or not funding for arts and culture projects is inclusive enough of all ethno-cultural communities in Canada, with about three in ten who say it is inclusive enough (32%) and just under three in ten who say it is not inclusive enough (27%). Forty-two percent are unsure.

### **EQUALITY OF PARTNERS**

Nearly two in three Canadians (66%) agree that we should ensure that First Nations, Inuit and Métis peoples are full and equal partners in Canada's efforts to confront the climate crisis. Over one in two Canadians agree (54%) that pollution, environmental hazards, and loss of biodiversity disproportionally affect racialized and First Nations, Inuit, and Métis communities.

### **CANADIAN GOVERNMENT DOING ENOUGH**

Canadians are split when it comes to whether or not the Canadian government is doing enough to reduce the effects of global climate change, with about one in three who agree (30%) and one in three who disagree (34%) with this. Canadians who identify as racialized Individuals were more likely to agree with this statement (mean of 5.6) than Canadians who identify as white (mean of 4.5).

#### **EFFECTS OF CLIMATE CHANGE**

Nearly six in ten Canadians (56%) agree that the effects of climate change can be felt in their community, with about one in ten (11%) who disagree with this. Canadians from British Columbia (mean of 7.4) are more likely to agree with this than Canadians from the Prairies (mean of 6.2).



#### **DISPROPORTIONATE IMPACTS**

Just over one in two agree that an Office of Environmental Justice should be created to address the disproportionate impacts of pollution and loss of biodiversity on low-income, racialized and other marginalized communities (52%). A similar proportion agree that a National Strategy should be created to advance environmental justice and to assess, prevent and address environmental racism (54%).


