The next matter is the assault incident which occurred on October 8th, 2021 at approximately 8:30 p.m. at 29 Queens Quay in Toronto. Just by way of background, this assault involves a same sex couple with a young child and the Crown has classified this as falling into the category of a hate crime given the utterances made by the accused to the victims. The facts the Crown relies on are as follows: On October 8th, 2021

at approximately 8:30 p.m. the victim and his same sex partner and their **minor's age** old son were out enjoying their usual nightly walk near their condominium at **Complainant's address**. The victim and his partner noticed the accused approaching them on foot, yelling that he was part of a SEAL Team sec and he was here to kill faggots. In response to seeing the accused the party of three began walking to their building so as to avoid any confrontation with the male. The accused immediately walked up to the three, leaned down and put his face down at the level of the three year old and yelled, "Do you think I'm going to hurt the child." The accused then threw down his backpack and took up a fighting stance towards the victim as if preparing to attack him. Fearing for the safety of his son the victim pushed the accused away. In reaction to the accused being so close, the **minor** fell and suffered a small scratch on his cheek. The victim, his partner and their son quickly made their way to the lobby of their building. While trying to enter the accused caught up to the victim in the vestibule and struck the victim in the face with a closed fist. The accused also spit on the victim on the back of his head. The victim defended himself and with the assistance of two unknown males was able to remove the accused from the vestibule. The victims then retreated into the lobby of the building where police were called. The accused returned and kicked the door of the building and fled. No damage was caused to the door. Officers arrived, an investigation was commenced and video surveillance from the victim's lobby was reviewed. The officers

recognized and identified the accused from the surveillance. A warrant was subsequently sought for Mr. Egal's arrest. He was of no fixed address. The adult victim didn't suffer any injuries other than soreness to his face and arms. The three year old child suffered a small scratch to his cheek. No one required medical attention. Mr. Egal was located on October 10th, 2021 and placed under arrest, taken to 51 Division, charged and held for a bail hearing.
