


		CLAYTON ASTOFOROFF: Guilty.
		CLERK OF THE COURT: And you are lastly charged
		on or about the 22^{nd} day of May, 2021, at the
15		Town of Englehart in the said Region, did commit
		an assault on Zu Jing Li, contrary to s. 266 of
		the Criminal Code. How do you plead?
		CLAYTON ASTOFOROFF: Guilty.
		THE COURT: I am sorry, I did not get that, can
20		you repeat your plea, please?
		CLAYTON ASTOFOROFF: Guilty.
		THE COURT: Thank you. Please listen carefully,
		the Crown will read in a summary of the facts.
		MR. WARSI: Your Honour, this matter does have
25		some aggravating features, so it was agreed upon
		that I would be reading in the full facts. I
		also did, I realized that we recently received
		the victim impact statement and I did just
		forward that to Madam Clerk. And I didn't
30		receive any indication that it was - basically I
		received an indication that it should just be
		filed, that she did not wish to read it out loud.

So I did submit it to Madam Clerk now and I am requesting that it be submitted. I will.... THE COURT: Well, I think we need to make a finding of guilt before we deal with sentencing. MR. WARSI: Right, okay. Right, sir. So the facts are as follows. On the 22nd of May, 2021 at approximately 5:02 p.m. the victim, Jing Li Zu, also known as Anna, attended her plot of land located behind Address While on her property her dog defecated on the neighbour's hard at which time the neighbour, Clayton Astoforoff, came outside intoxicated and upset. Mr. Astoforoff began yelling at the victim and made several racial slurs.

In a continued angered state Clayton then threw his lit cigarette at the victim, narrowly missing her arm as she moved it out of the way to avoid being burnt. Clayton then swung his fist at the victim's face while yelling, "I will punch you in the face, go back to f'ing China." And I did say f'ing, I mean the f word as is commonly known. The victim had to jump out of the way to avoid being punched in the head. These actions caused the victim to be fearful for her safety and the safety of her dog. Clayton then took a shovel and threw her dog's feces on her plants and began striking her newly planted spruce tree with a shovel, causing damage to the tree. Estimated cost of the damage was approximately \$100.
