30 MR. TUPPER: Okay. So that we are going to deal with the second set of allegations now, Your Honour, and Mr. MacMillan. The accused in this matter, Mr. MacMillan, was a client in the O'Neil Program. That runs out of the Seaton House men's

shelter and it's a program which is directed
towards recovering alcoholics. Mr. MacMillan was
banned from the program at some point due to
having assaulted a member of staff, and he was
ultimately expelled from both the O'Neil Program
and banned from attending at the Seaton House
men's residence which is located at 339 George
Street in the City of Toronto, Ontario.

On Wednesday, August 5th, 2020 at about 11:30
p.m., Mr. MacMillan and the complainant, whose
name is Dion Myers, were both located at the
Seaton House at 339 George Street in Toronto.

This is the location of the Seaton House, the
adult men's shelter. The complainant is a
frontline employee with the Seaton House staff.
And it's alleged as you heard that Mr. MacMillan
was a client that had been banned from the
property for 13 days. At the time that this
20
incident occurred he was not legally allowed back
on the property of the Seaton House.

It's alleged that Mr. MacMillan had been drinking
and he was on scene in the lobby of the Seaton
House trying to re-enter the O'Neil Program. Mr.
MacMillan was escorted off the property by Mr.
Myers and other staff members. As he was being
escorted off the property, it's alleged Mr.
30
MacMillan singled out Mr. Myers, who is a black
gentleman, and stated the following: "You're a
fucking nigger. I'm going to wait for you in the
parking lot and I'm going to kill you."

The complainant was in fear for his safety and contacted the police. The police attended. An investigation was begun. Mr. MacMillan was subsequently arrested and taken to 51 Division where he was charged at that time with the offence before the court, and he was released on an undertaking in relation to these offences. So that's the facts on the second set of allegations.

THE COURT: Are those facts basically correct, Mr. MacMillan?

MATT MACMILLAN: Yes.

THE COURT: So I am going to make a finding of guilt on that matter relating to uttering a death threat.

MR. TUPPER: All right, this is the third and final set of allegations, Your Honour. June 8th of '21, these are the North York allegations.

THE COURT: Yes.
